Synopsis: Summary of complaint received regarding a potential murder for hire.

Details: On April 3, 1998, the Philadelphia office of the Federal Bureau of Investigation (FBI) received a complaint from RICH COSTELLO of the Fraternal Order of Police (FOP) regarding KILLERCOP.COM, a site on the Internet that offers a monetary reward for the killing of police officers. The homepage for KILLERCOP.COM states that an individual has already claimed a reward and KILLERCOP.COM found the claim to be valid.

Investigation of KILLERCOP.COM revealed that EARTHLINK was the Internet service provider for KILLERCOP.COM until March 21, 1998. The administrative contact for KILLERCOP.COM is STEVEN SUTCLIFFE, DOB: 01/22/64, SSN: 450-88-3714, of 1054 S. Bedford, Los Angeles, California 90035, telephone number (310) 854-9029. SUTCLIFFE has not been contacted by the Philadelphia office.

KIRSTEN HANSEN, director of legal affairs for EARTHLINK, telephone number (626) 296-3037, was interviewed regarding KILLERCOP.COM. HANSEN stated MIKE GRASSO of the LOS ANGELES POLICE DEPARTMENT (LAPD) made complaints to EARTHLINK regarding KILLERCOP.COM, which resulted in EARTHLINK canceling their service. After KILLERCOP.COM was banned by EARTHLINK, SUTCLIFFE made death threats to EARTHLINK employees in the Information Technology division.

Investigation to date reveals that NETCBC.COM is the current Internet service provider for KILLERCOP.COM. The technical contact for NETCBC.COM is STEVE WYSONG, Computer Business Center, 2811 Oceanpark Blvd, Santa Monica, CA 90405, telephone number (310) 396-2797, e-mail address, swain@NETCBC.COM.
