Examination of F.B.I. Agent Jeffery Raymond Cugno By U.S. Attorney:

TRANSCRIPT PAGE 54:

Q. With respect to that aspect, the threatening communications, did you endeavor to determine whether or not there was a prior pattern of conduct by Mr. Sutcliffe with respect to communications of a threatening nature on the Internet?

A. Yes, I did.

Q. Tell us what you found?

A. We found that there had been a previous posting of another website that had also been registered to Mr. Sutcliffe.

Q. The name of the site was what?

A. **www.killercop.com**

F.B.I. Agent Jeffery Raymond Cugno

TRANSCRIPT PAGE 57:

Q. Can you tell us any of the specifics with respect to that website threats to kill police officers?

A. **The detectives [of the LAPD] also presented to me copies of instruments and tools, weapons that were for sale on the website.**

Q. Copies of the actual weapons or copies of the, descriptions and photos that had appeared on the website?

A. Copies of the photos and the descriptions of those weapons and tools.

Q. Tell us very generally what the weapons that were listed on that website were?

TRANSCRIPT PAGE 58:

A. I'm referring now to the photocopies that were presented to me by those detectives [of the LAPD] of the pictures and descriptions of those tools. On one particular entitled "**Knife-gun**," there are four

photos. The description of the weapon is virtually indistinguishable from a combat or hunting knife, this weapon is capable of firing six 22 caliber rounds from a revolving cylinder, employing a firing mechanism concealed in its handle...

CROSS EXAMINATION OF F.B.I. Agent Jeffery Raymond Cugno
TRANSCRIPT PAGE 64:

Q. For instance, you testified about a bunch of weapons that were listed, you said, for sale on the website?

A. Correct.

Q. The fact of the matter is there wasn't anything for sale on the website; isn't that true?

A. They were listed for sale.

Q. Okay, but *you forgot to tell the judge* that there was also some language on every page, at the bottom of the page. Why don't you tell the judge now what that language said on every page? A. I don't know if it was on every page but on the page you're showing me it notes **fiction ad and/or personality parody.**

Q. Okay, and that was on the picture of the Bloodsucking Pen?

A. **Correct.**

Q. All right. And then on the Key Chain Knife it says what at the bottom of the page?

A. **Fiction, ad and/or personality parody.**

Q. Okay, and at the bottom of the page of this Safety Pin Key it says **fiction, ad and/or personality parody; right?**

A. **Correct.**

Q. And then here's another one that says Cuff Link Key; right?

A. Correct.

Q. And there's a picture of - - I don't know what that's a picture of, but it's a picture of something, at the bottom there it says **fiction, ad and/or personality parody; right?**

A. **Correct.**

CROSS EXAMINATION OF F.B.I. Agent Jeffery Raymond Cugno
TRANSCRIPT PAGE 65-66:

Q. Okay. Now also there was another page that you didn't even talk about and that was the -- let me get my notes here. There was a lot of stuff, there was a lot of other stuff on there which was maybe not a good attempt at humor but an attempt at humor; isn't that true?

A. I'm not sure what the attempt was, sir.

Q. Well, there was one on there called the Bee Stinger, which was a big bow-like device that you're supposed to fill full of bees and then if the cops came at you, you shot the bees at them, did you see that?

A. I don't remember that.

Q. Did you see the site?

A. **I saw the contents that were provided to me.**

Q. Okay, well, then you weren't provided with the entire contents, were you?

A. I don't know. I was provided with the contents of the website.

Q. What you do know is you were provided with those contents, which the members of the LAPD wanted you to be provided with, right?

A. I don't know how to answer that, sir.

Q. **Who did you get this stuff from?**

A. **Detectives from the Los Angeles Police Department.**

Q. Did you ask them if there was anymore to the website that you might want to take a look at?

A. No, I did not.

Q. Did you ever go to that website?

A. I did not.

Q. **Okay. Because you can't get to it anymore?**

A. Correct.

Q. All right. In fact, there wasn't any charges brought in Los Angeles against the defendant for that website, was there?

A. **No, there were not**
